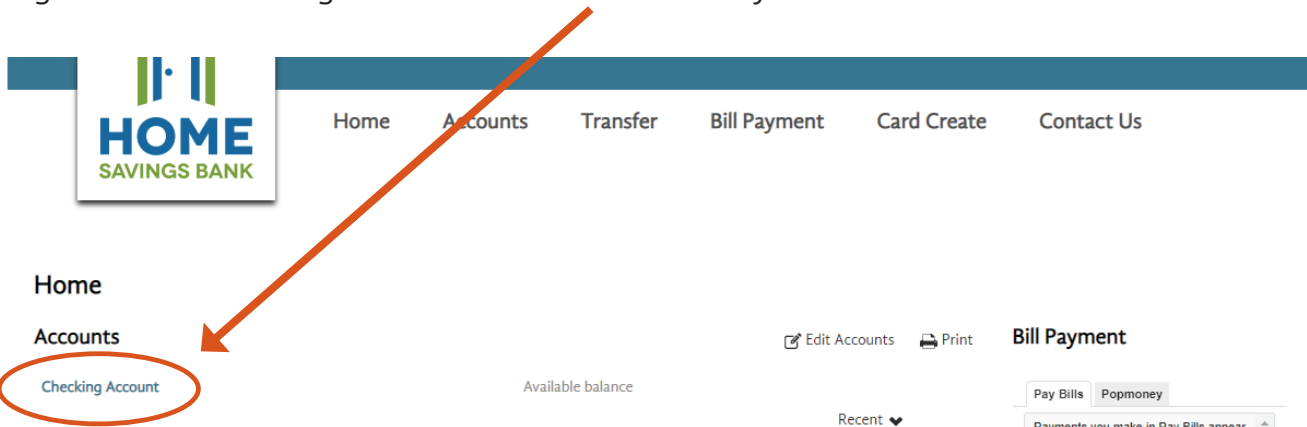


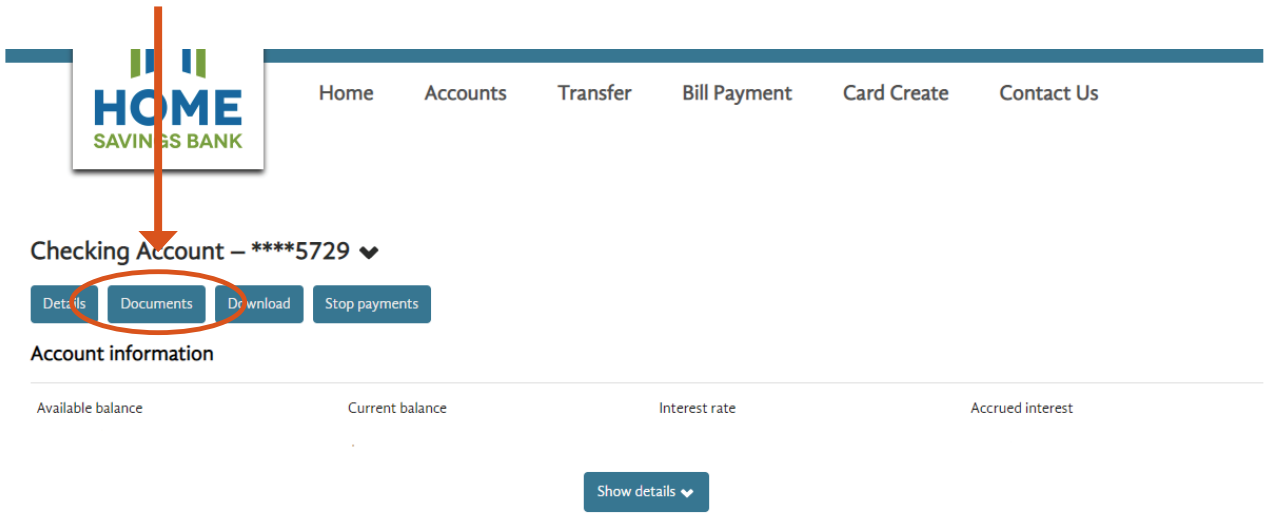


Signing up for eStatements when you *already* have online banking
